#### **PRESENTATION**

As far as industrial property rights are concerned, legislation has recently been developing in a new way, both in Europe and in Italy. On the one hand, the so-called "Patents package" - namely the European rules on Unitary Patents and Unified Patent Court – is about to enter into force. On the other hand, Stability Act 2015 introduced also in Italy the optional scheme of the so-called Patent Box, which envisages low tax regimes for income deriving from use and/or transfer of "intellectual works, industrial patents, trademarks, as well as from processes, formulae and information linked to experience gained in the industrial, trade or scientific field that may be protected by law". With regard to the "Patent Box" adopted in the other European countries, the legislative authority extended application of the optional scheme virtually to all intangibles. This meeting, promoted by Friuli Venezia Giulia Autonomous Region and by Trieste University's Department of Legal, Language, Interpretation and Translation Studies, aims at taking stock of these legislative news, carried out in the strategic field of Economy at European and regional level, by hosting debates among scholars, professionals and enterprises.
